No. 49/49/2010-4IB-I. - The Governor of Haryana hereby makes the following amendments in the 'Land Pooling Scheme' notified by the Industries and Commerce Department vide Notification No. 49/49/2010-4IBI dated 14.08.2012, with immediate effect:

Para No.	Existing provision	Amended provision
2 (ii)	The landowner(s) would be eligible to participate in the Land Pooling Scheme only if a minimum of $\frac{1}{2}$ acre or more of his/ their land is acquired;	The landowner(s) would be eligible to participate in the Land Pooling Scheme only if a minimum of one acre or more of his/ their land is acquired;
2(iv)	The option for the Land Pooling Scheme will have to be exercised by the landowner(s) in writing in the prescribed form within a period of 4 months of the publication of Section 4 Notification.	The landowners would be permitted to opt for the Scheme at any time after issue of Section 4 Notification, but within one month from the date of determination of compensation amount of land by the Committee headed by the Divisional Commissioner concerned. The Divisional Commissioners shall hold the meetings for determination of the compensation amount at least three months prior to the last date for announcement of the Award. Further, the compensation amount so determined or proposed to be awarded by the Land Acquisition Collectors would be made known to the landowners so that they are in a position to make informed decisions regarding exercise of their option under the Scheme.

The Landowner shall also have the option to opt for the 'Land Pooling Scheme' in respect of part of his land being acquired and accept the 'compensation along with the R & R Benefits' in respect of the balance land provided: (i) The minimum land being acquired is one	The Landowner shall also have the option to opt for the 'Land Pooling Scheme' in respect of part of his land being acquired and accept the 'compensation along with the R & R Benefits' in respect of the balance land in any ratio subject to a minimum of one acre land being offered under the 'Land Pooling Scheme'; Provided that once having exercised the option for the 'Land Pooling Scheme' after
