Subject: Regarding-De-notification/Discontinuation of the Scheme - "Scheme for Assistance for Startups in the State" under Haryana Enterprises & Employment Policy 2020 dealt by the MSME department.

Kindly refer on the subject noted above.

1. It is informed that the State Government has notified the Haryana State Startup Policy 2022 vide notification no. Admn/459/1SIT/17601, dated 07.07.2022. Further, 06 schemes under the Haryana Startup Policy 2022 namely:- Lease Rental Subsidy, Patent Cost Reimbursement, Net SGST Reimbursement, Assistance in Acceleration Programs, Reimbursement for Cloud Storage, and Seed Funding for Startups have been approved by the Hon'ble Chief Minister, Haryana on 18.08.2023 and also approved by the concerned Standing Finance Committee(SFC-B) chaired by W/ACS Finance, the Minutes of the Meeting which is conveyed vide U.O NO.4/74/2013/SB&FM(FD) dated 11.01.2024.

2. It is further informed that the scheme namely "Scheme for Assistance for Startups" bearing notification no. 25/05/2020-4IB-I dated 11.10.2021 under the Haryana Enterprises & Employment Policy-2020 which is being dealt by the MSME is to be discontinued to avoid duplicity of incentives and dual budget implications thereof.

3. You are therefore, requested that any application received till 31.07.2024 (end of the day), under the "Scheme for Assistance for Startups in the State" may be dealt by the MSME department and thereafter any application received from 01.08.2024 onwards will be administered/dealt by Industries and Commerce Department and accordingly, all the existing 06 segments namely Interest subsidy, lease rental subsidy, Seed Grant, Net SGST Reimbursement, acceleration programs support, cloud computing/storage expenses reimbursement under the "Scheme for Assistance for Startups in the State" dealt by MSME department, under HEEP 2020 shall be de-notified/ discontinued w.e.f. 01.08.2024 by MSME department.
