## NOTIFICATION

No. 25/05/2020-4IB-I

In pursuance to provision under annexure 4 of Chapter 8 of the Haryana Enterprises & Employment Policy, 2020 notified in Gazette vide No.25/05/2020-4IB-I dated 29.12.2020, the Governor of Haryana is pleased to notify "Industrial Infrastructure Development Scheme" (IIDS) as per details given below:-

# 1. Objectives of the Scheme;

As envisaged in the Haryana Enterprises & Employment Policy, 2020, and for facilitating balanced regional and sustainable development across the State, it has been decided to provide fiscal incentives to assist dispersal of industry to the industrially backward areas of the State and infrastructure led geographical dispersal driven by Rural functional Clusters. The infrastructural support to Mega and Ultra Mega Project shall be decided by HEPB.

# 2. Infrastructure Available under the Scheme:

IIDS for providing adequate width of road connectivity with nearest State/ National highway, water supply, independent power feeder & fibre optic connectivity up to the periphery of rural functional clusters set up in 'B', 'C' and 'D' category blocks at State expenses.

# 3. Eligible Projects:

The following categories of organizations shall be eligible for creating Infrastructure in respect of road, independent power feeder and water supply etc. under the said scheme are Promoter/SPV of Rural Functional Cluster.

# 4. Quantum of Assistance;

100% assistance shall be provided for creating the Industrial Infrastructure such as:-

- a) Providing adequate width of roads connectivity with nearest State/National highway.
- **b)** Provision of adequate water supply i.e. laying of requisite pipeline and related infrastructure.
- c) Provision of independent power feeder.

d) Provision of Fibre Optic Connectivity and Trunk Sewer.

# 5. Definitions:

# a) Rural Functional Cluster:

Cluster developed by a group of minimum 10 enterprises in rural area within jurisdiction of village panchayat resulting in enhanced economic activity and local employment in 'B', 'C'& 'D' category blocks.

# 6. Eligibility:

i. The cluster should have obtained CLU/NOC if applicable.

# 7. Commencement and Applicability:

The scheme shall commence with effect from 01.01.2021 and shall remain in operation till for a period of 5 years or till the time Government decides to discontinue this scheme, whichever is earlier.

# 8. Implementing Agency:

HSIIDC/PWD(B&R)/PHED/Irrigation & Water Resources or any State Agency appointed by the Sanctioning Authority or self-execution by the promoter (wherever permitted by the Implementing Agency), to carry out all the industrial infrastructure related development works under the scheme.

# 9. Procedure to apply for financial assistance under the scheme:

Promoter/SPV of the clusters will apply to the Director/ Director General, Industries & Commerce for creation of infrastructure upto the premises of the project/ industrial estate/park on the prescribed application form enclosed as Annexure-I. After receipt of application, the concerned implementing agency will be requested to prepare estimates for sanction and releasing the funds for execution of works. The promoter may also execute the work himself (selfexecution) at the estimate prepared by the Govt. agency, if permitted by the concerned agency under its supervision. The supervision charges shall be borne by the promoter. However, the funds will not be released in advance to the promoter in case of self-execution.

# 10. Competent Authority to sanction the project:

A committee under the chairmanship of Administrative Secretary, Industries &

Commerce is constituted comprising of the following members. The project assisted under the scheme shall also be monitored by the Committee:-
