Notification

The 23rd July, 2024

No. 25/05/2020-4IB1.— In pursuance to the provision under Section - 2 (Sub-Section 2.3) of the Haryana State Startup Policy 2022 notified vide No. Admn/459/1SIT/17601 dated 07th July 2022, the Governor of Haryana is pleased to notify the *"Seed Funding for Startups Scheme"* for the Startups registered under the Haryana State Startup Policy 2022. The Scheme related to "Seed Funding for Startups" will be as under:

1. Objective

The Government of Haryana has always followed a proactive approach to facilitate Startup entrepreneurs for ease of doing business in Haryana. In order to achieve the same, State has undertaken precise policy-level interventions to position Haryana as a pre-eminent investment destination and notified the Haryana State Startup Policy 2022 with a focus on the creation of a world-class 'Startup Ecosystem' in the State.

Through this scheme, the State government intends to provide support in the form of "Seed Funding for Startups" to eligible Startups and facilitate the growth and strengthening of Startups in the State of Haryana.

2. Quantum of Assistance (Seed Funding for Startups)

In order to provide funding support to startups, financial assistance as Seed Grant would be provided to the Haryana based Startups:

- (i) Seed grant of up to INR 10 Lakh per startup for 100 startups in 'A' category blocks, 250 startups in 'B' category blocks, 750 startups in 'C' category blocks, and 1000 startups in 'D' category blocks would be provided under this scheme.
- (ii) The category of blocks will be applicable as per the block categorization given in Haryana Enterprises and Employment Policy 2020 and as amended from time to time.
- (iii) The Seed Grant shall be provided for validation of idea, proof of concept demonstration, prototype development, assistance towards traveling costs, and carrying out field/market research/ marketing or other initial activities to the selected startup.
- (iv) Assistance towards traveling cost would be limited to INR 50,000.
- (v) Assistance towards carrying out field/ market research would be limited to INR 50,000.
- 3. Exclusions:
 - (i) The expenses which are covered under other Fiscal Incentives for Startups under the Haryana State

Startup Policy 2022 i.e. Lease Rental Subsidy, Patent Cost, Net SGST Reimbursement, Assistance in Acceleration Programs & Reimbursement for Cloud Storage will not be covered under the Seed Funding scheme.

- (ii) Any administrative expenses such as office rent, remuneration of the founding team & employees, utility bills, daily travel & conveyance, and purchase of personal use equipment such as mobile phone, laptop, etc.
- (iii) Repayment of any loans or investments made by the Startup Entity, founding team, or any other person in the startup entity.
- (iv) Seed Funds shall strictly not be used by startups for the creation of any facilities viz. building construction, civil works, etc., and shall be utilized for the purpose it has been granted for.

4. Commencement

The Scheme shall commence with effect from the date of notification of the Haryana State Startup Policy 2022 i.e., 07.07.2022, and shall remain in operation for a period of 5 years i.e., 06.07.2027 or till the time the Government of Haryana decides to discontinue/ amend/ extend this scheme.

5. Eligibility Criteria for Startups

- (i) The Startup entity should be a "Category 1 Startup" registered with Startup Haryana, Industries & Commerce Department, Haryana as defined in the Haryana State Startup Policy 2022 and as given in 5 (ii) below.
- (ii) Category 1 Startups are defined as Startups registered with Startup Haryana in accordance with the eligibility criteria as mentioned below:
 - a. The entity should be registered & recognized as Startup from DPIIT and
 - b. Location: Address of the Registered Office of the Startup entity should be in Haryana.
- (iii) The Startup entity should have Haryana Udhyam Memorandum (HUM) for statistical purposes.
- (iv) The products or processes/ services of the Startup entity should not fall in the restrictive list as notified by State Government under the Haryana Enterprises and Employment Policy 2020 and as amended from time to time.
- (v) The policy/scheme is sector-agnostic and applicable to all Startups irrespective of their domains(s).
- (vi) Startups availing incentives under this scheme should not have availed similar incentives under any other State Government policy. Further, Startups availing incentives under this scheme will also not be eligible to avail similar incentives under any other State Government policy.
- (vii) For Travelling Cost
 - a. The travelling cost (domestic/ international) will include travel through AC 2 Tier/AC Chair Car, AC Bus or lower or Airfare in economy class for participation in conferences, seminars, trade fairs, exhibitions, or any events related to Startups.
 - b. Accommodation expenses, local travel, and any other participation fees will not be covered under this head.
 - c. Only founders, co-founders or directors of the startup will be eligible for the assistance and only two members will be eligible in a single trip.
- (viii) For Field/ Market Research: Assistance towards carrying out field/market research may include:
 - a. Expenses incurred in primary market research
 - b. Market survey on social media platforms.
 - c. Procuring research papers/ journals either online or offline.

6. Procedure for availing Incentive/ Benefit

- (i) The Startup Entity shall apply online on the web portal of the Department of Industries & Commerce, Government of Haryana for "Seed Funding for Startups" in the prescribed format (as per Annexure-I) along with the requisite supporting documents as prescribed under this scheme document.
- (ii) The application received shall be examined and in case of any deficiencies, the same will be communicated to the Startup Entity/applicant in their user account, and the applicant shall rectify the same within 10 working days of receipt of intimation from the Industries & Commerce Department, Haryana.
- (iii) In case the deficiencies are not removed by the Startup Entity/applicant or fail to submit requisite additional information within the above timelines, the application shall be deemed rejected/closed. Startup Entity/ applicant would be intimated the status in their user account.

(iv) The application after examination will be placed before the Evaluation & Approval Committee for consideration and approval. The Startup Entity will be called for a presentation of their Idea/Product/Service to the Evaluation & Approval Committee.

(v) The Evaluation & Approval Committee shall comprise of the following members:

Quorum of the Committee: The Quorum of the Committee shall be of 50%, out of which at least 3 members shall be from the State Government.

- (vi) The Evaluation & Approval Committee will examine the application for Seed Fund based on the Evaluation Criteria mentioned in section 7 of this scheme document and will approve/decide the grant to be provided under this scheme.
- (vii) Based on the decision taken on the application, an intimation will be sent to the Startup Entity/ applicant in their user account. The applicant would also be able to download the decision / sanction letter from the portal in reference to their application.
- (viii) The sanctioned amount will be credited into the Bank Account of the Startup Entity subject to the compliance of the terms of the approval / sanction letter, if any.
- (ix) Disbursal process: The amount of the Seed grant approved will be disbursed in 3 tranches, which will be 50% in 1st Tranche, 40% in 2nd Tranche & 10% in 3rd Tranche or as decided by Evaluation & Approval Committee with specific justification(s). The disbursement of the subsequent tranche will be post-submission of the utilization certificate of the grant disbursed in the previous tranche subject to the approval of the Evaluation & Approval Committee.
- (x) The Startup entity will be eligible for applying for a grant under the subsequent tranche post submission of the Utilization Certificate of at least 80% amount of the corresponding previous tranche. However, the amount will be disbursed only after the Startup Entity provides the utilization certificate of 100% amount of the corresponding previous tranche.
- (xi) Only those expenses incurred after the approval of the seed fund grant by the Evaluation & Approval Committee will be considered as valid expenditures under tranches 1, 2, and 3.
- (xii) Disbursement of 2nd & 3rd tranche: The Startup Entity is required to submit the interim progress report and utilization certificate to initiate the release of the subsequent tranche of funds. Once the sanction is accorded, the Startup Entity would continue to be eligible for 2nd/3rd tranche. The progress will be reviewed by Evaluation & Approval Committee as per the procedure defined in Section 6 (i to x) above.
- (xiii) In case of unsatisfactory performance of the startup, the Evaluation & Approval Committee may discontinue the seed fund support to the Startup for subsequent tranches.

(xiv) If an application of any Startup Entity is rejected by Evaluation & Approval Committee, then that Startup Entity may re-apply in the next quarter with an improved application.

7. Evaluation Criteria

The quantum of Seed fund to be provided will be decided based on the following evaluation criteria:

Note: To qualify, the startup should achieve a minimum of 60% marks as per the evaluation parameters defined above.

8. Time Limit to Apply

For availing the seed funding under this scheme, the startup entity is required to apply/ submit an online application on the web portal of the Department within the policy period. Further, it is clarified that the application should be submitted before the expiration of the policy i.e. 06.07.2027.

9. Competent Authority for Sanction

The Evaluation & Approval Committee under the chairmanship of the Director/ Director General, Industries & Commerce Department, Haryana, or as decided/ delegated by the Government of Haryana from time to time, shall be the competent authority for sanction of the fiscal benefit under the scheme.

10. Timelines for Processing & Decision of Applications

The applications received in a particular quarter would be considered for evaluation in the subsequent quarter by the Evaluation & Approval Committee.

11. Interpretation/ Clarification/ Modification

The Administrative Secretary, Industries & Commerce Department, Haryana will be the final authority for clarifying/ resolution of any doubts relating to the interpretation of any term or any provision arising under this scheme. The decision in this matter shall be final and binding for all stakeholders in such cases.

12. Appeal

An applicant may file an appeal to the Administrative Secretary, Industries & Commerce Department, Haryana against an order passed by the Competent Authority within a period of 30 days from the date of communication of the order. The order(s) passed by the Administrative Secretary, Industries & Commerce Department in such appeal shall be final.

13. Penal Action

At any time, if it is found that the Startup entity has claimed/ availed any form of assistance/ benefit (Fiscal/Non-Fiscal) from the Government based on any false/ fabricated information or involved in any malpractices/ fraudulent activities; the registration of the Startup entity will be summarily revoked, and the Startup entity shall refund the entire amount of the assistance granted/ availed along-with the compound rate of interest @ 12% per annum. In addition, the Startup entity/ applicant will also be liable to face legal action and will be debarred to avail any incentives/ assistance under any other policy/ scheme of the State Government in the future.

14. Head of Expenditure

The expenditure shall be met under the Scheme Head i.e. "P-01-19-2852-07-202-87-51-N-V" of the Industries & Commerce Department, Haryana.
