3. The headquarter of the Dispute Settlement Committee shall be at Chandigarh.
4. **Role and Functions of the Committee:**
 - (i) To decide the policy guidelines, process & mechanism to settle existing disputes/litigations pertaining to various departments as per the provision of Enterprises Promotion Policy 2015.
 - (ii) The committee shall take up the long standing disputes of the industrial units with various state departments, with Arbitrator, Tribunal & Courts pending for more than one year. The committee shall evolve scheme to settle the disputes out of the court, if found feasible.
 - (iii) The industrial unit shall submit its request to the Dispute Settlement Committee through E-Biz portal of State i.e. www.investharyana.gov.in
4. **Meeting**

The committee shall meet once in two months or earlier if required.
5. TA/DA by the members shall be drawn by the members from their respective departments.
