No. 25/17/2019-4IB-I.— In continuation of Notification No. 49/43/2015-4IB1 dated 09.01.2019, the Governor of Haryana is pleased to modify the “Power Tariff Subsidy” scheme with an objective to provide affordable power supply to the enterprises located in the State with the provisions given hereunder:

1. Quantum of Power Tariff Subsidy:

An enterprise located in ‘C’ & ‘D’ category blocks having industrial connection of connected load of 20 KW or less shall be provided Power Tariff Subsidy @ Rs. 2/- per unit.

2. Commencement and Applicability:

The Scheme shall be applicable w.e.f. 1st November, 2018 and shall remain in operation till it is superseded by the Government.

3. Eligibility Criteria for the Enterprise:

- i. All existing and new industrial enterprises situated in ‘C’ & ‘D’ category blocks of the State having connected load of 20 KW or less shall get the benefit of Power Tariff Subsidy.
- ii. The enterprise shall be eligible for this benefit till it remains in production.

4. Procedure:

The enterprise will not be required to apply for availing the benefit. The Power Companies/Utilities *i.e.* UHBVN/DHBVN shall provide this benefit by deducting the subsidy amount in the electricity bills.

5. Provision of Funds:

The amount of Power Tariff Subsidy granted by the UHBVN/DHBVN shall be reimbursed by the Industries & Commerce Department from its budget allocated under the head *i.e.* “2851-Village and Small Industries-102-Small Scale Industries-[65] Incentives for Development of Industries under new Enterprises Promotion Policy 2015-(11)-Subsidies”.

No.49/43/2015-4IB-I “Power Tariff Subsidy” scheme issued vide Notification No.49/43/2018-4IB-Ib dated 12th June, 2018 is hereby repealed and it has been decided that all the applications received in response to the notification dated 12.06.2018 shall not be considered/processed for release of Power Tariff Subsidy. A new scheme of Power Tariff Subsidy has been introduced and the direct benefit shall be provided to the eligible Micro & Small units situated in ‘C’ & ‘D’ category blocks by deducting the subsidy amount at the source by UHBVN/DHBVN. The applicant unit shall not be required to apply for the benefit.
