4. To take the assistance of knowledge partner for suggesting mechanism for implementation of various provisions under Haryana Enterprises Promotion Policy-2015 in better way.
5. To suggest the measure/remedial action on the hurdles/bottlenecks to Haryana Enterprises Promotion Board for taking policy initiative/ decision on the part of concerned Administrative Department.
